OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN. PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW. THIS SWEEPSTAKES IS INTENDED FOR VIEWING IN THE UNITED STATES ONLY AND SHALL ONLY BE CONSTRUED AND EVALUATED ACCORDING TO UNITED STATES LAW.

The “Great Home” Giveaway (the “Sweepstakes”) is intended for legal residents of Ohio and shall only be construed and evaluated according to U.S. law. Do not enter this Sweepstakes if you are not a resident of Ohio at the time of entry. By participating, Entrants agree to abide by and be bound by these Official Rules and the decisions of the Sponsors, which are final and binding in all matters relating to the Sweepstakes. Winning the Grand Prize (as described below) is contingent upon fulfilling all requirements set forth herein.

Sponsors/Administrator: The Sweepstakes is sponsored by HER Realtors, 4261 Morse Rd, Gahanna, OH 43230 and Trinity Homes, 2700 East Dublin Granville Rd., Columbus, OH 43231 (the “Sponsors”) and administered by American Sweepstakes & Promotion Co., Inc., 300 State St. Suite 402, Rochester, NY 14614 (the “Administrator”).

Eligibility: Entrants must be legal residents of Ohio, who are at least 21 years of age or older at the time of entry (“Entrant”). Employees of the Sponsors, IMG, Ohio State University, and the Administrator, their immediate families (parent, child, sibling or spouse) and/or household members and any other persons or entities associated with this Sweepstakes are ineligible to enter or win. Void outside of the state of Ohio or where prohibited/restricted by law.

How to Enter: The Sweepstakes begins at 12:00:01 a.m. Eastern Time (“ET”) on August 31, 2017 and ends at 11:59:59 p.m. ET on October 28, 2017 (“Sweepstakes Period”). The Sponsors’ computer is the official time-keeping device for the Sweepstakes. There are two (2) methods of entry for the Sweepstakes as follows:

1. **1). Online:** Eligible Entrants can enter the Sweepstakes by visiting www.HerRealtors.com/TrinityHomeGiveaway (the “Website”) and completing the Sweepstakes registration form. The registration form will require an Entrant to enter the following information: first name, last name, mailing address, city, state, zip code, phone number, and e-mail address. All of the aforementioned information fields are required. Incomplete information may result in disqualification of entry. All entries must be received by the Sponsors by 11:59:59 p.m. ET on October 28, 2017 in order to be eligible. By properly completing the Sweepstakes registration form the Entrant will receive one (1) Sweepstakes entry.

2). Event Registration: Eligible Entrants can enter the Sweepstakes by attending the Parade of Homes and register at any Trinity Home, Homewood, or Ambassador model home.

3). Event Registration: Eligible Entrants can enter the Sweepstakes at Fan Fests held outside of Ohio State Football Stadium (September 9, 16, 23, & October 7, 28, 2017).

4). Event Registration: Eligible Entrants can enter the Sweepstakes by attending “The Ohio State Four Miler” on October 22, 2017 and registering at Trinity Homes / HER Realtors Booth.

Limit one (1) entry per person regardless of method of entry. All entries become the property of the Sponsor and will not be returned. All required information must be completed to enter and to be eligible to win. Incomplete entries will be disqualified. Proof of entering information at the Website is not considered proof of delivery to or receipt by Sponsor of an entry. Internet entries must be made by the entrant only at the Website. Entries made by any other individual or any entity, and/or originating at any other web site or email address, including, but not limited to, commercial Sweepstakes subscription notification and/or entering service sites, will be declared invalid and disqualified for this Sweepstakes. The use of automated entry devices is prohibited and no mechanically reproduced entries are allowed; all such entries are void. Released Parties are not responsible for: late, incomplete, incorrect, delayed, garbled, undelivered, or misdirected entries. Sponsor reserves the right to disqualify any person or email address that submits more than maximum allowed entries. All entries become the exclusive property of Sponsor and will not be acknowledged or returned. By participating, you consent for Sponsor to obtain, use, and transfer your name, address and other information for the sole purpose of administering this Sweepstakes. All information submitted by Entrants will be treated according to Sponsor’s privacy policy, available at <http://www.herrealtors.com/pages/her-realtors-terms-of-use>. By participating in the Sweepstakes and providing your email address, Entrants hereby agree to Sponsor’s collection and usage of their personal information and acknowledge that they have read and accepted Sponsor’s Privacy Policy.

General Conditions: If for any reason the operation or administration of this Sweepstakes is impaired or incapable of running as planned for any reason, including but not limited to (a) infection by computer virus, bugs, (b) tampering, unauthorized intervention, (c) fraud, (d) technical failures, or (e) any other causes beyond the control of the Sponsor or Administrator which corrupt or affect the administration, security, fairness, integrity or proper conduct of this Sweepstakes, the Sponsor reserves the right at its sole discretion, to disqualify any individual who tampers with the entry process, and to cancel, terminate, modify or suspend the Sweepstakes in whole or in part, at any time, with or without notice and, if Sponsor elects not to terminate the Sweepstakes, award the Prizes (defined below) using all non-suspect eligible entries received as of, or after (if applicable) this cancellation, termination, modification or suspension date, or in any manner that is fair and equitable and best conforms to the spirit of these Official Rules. Sponsor reserves the right, at its sole discretion, to disqualify any individual deemed to

be (a) tampering or attempting to tamper with the entry process or the operation of the Sweepstakes or Sponsor's Website; or (b) acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner.

Failure by the Sponsor to enforce any provision of these Official Rules shall not constitute a waiver of that provision.

Released Parties assume no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of, entries. Released Parties are not responsible for any problems or technical malfunction of any telephone network or telephone lines, computer online systems, servers, or providers, computer equipment, software, failure of any email or entry to be received by Sponsor on account of technical problems, human error or traffic congestion on the Internet or at any Website, or any combination thereof, including any injury or damage to Entrant's or any other person's computer relating to or resulting from participation in this Sweepstakes or downloading any materials or accessing any website relate to this Sweepstakes. Entrant further agrees that in any cause of action, the Released Parties' liability will be limited to the cost of entering and participating in the Sweepstakes, and in no event shall the Released Parties be liable for attorney's fees. Entrant waives the right to claim any damages whatsoever, including, but not limited to, punitive, consequential, direct, or indirect damages.

Drawing and Notification: Two (2) potential Prize Winners will be selected from among all eligible entries received, in a random drawing by the Administrator, an independent judging organization, whose decisions are final in all matters relating to this Sweepstakes. The drawing will be completed on or about November 2, 2017. Odds of winning will depend on the total number of eligible entries received. The potential Winners will be notified by the Administrator via telephone, and/or email.

Prizes & Prize Conditions: There will be two (2) Prizes awarded. Each Prize Winner, upon the Administrator's confirmation of eligibility, will receive two (2) tickets to the

November 11, 2017 Ohio State vs Michigan State football game (the "Game"; Ohio Stadium). At a time specified by the Sponsor (either before or during the Game) the two (2) finalists will participate in a football Target Toss game at Fan Fests which will be conducted outside of Ohio Stadium (exact location also designated by Sponsor). The goal of the Target Toss is to successfully toss the football through the target (the "Goal"). See complete Target Toss game instructions, descriptions, and restrictions below.

The Administrator will perform a random drawing (prior to the Game) to determine the order in which the Winners will participate in the Target Toss game. Each Winner will only be allowed one (1) attempt at the Target Toss game. Should the first Winner successfully complete the Goal, the second Winner will not get an attempt at the Target Toss game.

- -If the Goal is completed, the Winner who completed the Goal will receive a new Trinity Home valued at \$250,000.00. Location of home to be determined by Trinity Homes. Winner has the option to upgrade. All upgrades will be at winner's expense. Winner must make all color and option selections within thirty days of prize being awarded.

Additional Target Toss winner options:

- Winner has the option to apply \$250,000 towards the purchase of any new Trinity Home.

-If the Goal is not completed by either Winner, both Winners will receive two (2) tickets to the February 21-26, 2018 Buckeye Cruise for Cancer. Prize package consists of:

- Two (2) roundtrip standard economy airfare tickets from Columbus Ohio.
- The Buckeye Cruise departs from Ft. Lauderdale to Key West and the private island of Labadee. It is 5 nights and includes port charges, taxes and prepaid gratuities as well as airfare and a cabin for 5 nights for two people.

The Prize has a The Approximate Retail Value of each Prize package of ("ARV") \$2,500.

A \$2500.00 cash prize may be selected in lieu of the Buckeye Cruise for Cancer package by all finalists not making the Target Toss Goal.

Additional Target Toss Game Rules & Restrictions: Each toss must be from a maximum distance of twenty-five (25) yards, on the fly, through a target opening measuring a maximum of twelve (12) inches in diameter and placed a minimum of thirty-six (36) inches in height above the playing surface. No part of the contestant's body or clothing may come in contact with the demarcation lines/spots prior to throwing the ball. One (1) toss per finalist. If the Goal is achieved the game is over and the finalist will be declared the potential winner pending further verifications by the administrator.

Entrants agree to the following restrictions:

The Sponsor reserves the right at its sole discretion to substitute the Prize with another Prize of equal or greater value. IN NO EVENT WILL RELEASED PARTIES BE RESPONSIBLE OR LIABLE FOR ANY DAMAGES OR LOSSES OF ANY KIND (INCLUDING WITHOUT LIMITATION, DIRECT, INDIRECT, INCIDENTAL, CONSEQUENTIAL, OR PUNITIVE DAMAGES) ARISING OUT OF PARTICIPATION IN THIS SWEEPSTAKES OR THE ACCEPTANCE, POSSESSION, USE, OR MISUSE OF, OR ANY HARM RESULTING FROM THE ACCEPTANCE, POSSESSION, USE OR MISUSE OF THE PRIZE.

The waiver by Sponsor or Administrator of any provision of these Official Rules shall not constitute a waiver of any other provision herein. The rights and obligations hereunder may not be assigned by Entrant, whether by operation of law or otherwise, without the prior written consent of Sponsor, and any attempted assignment in violation of the foregoing shall be null and void. These Official Rules shall be binding upon, and inure to the benefit of, the permitted successors and assigns of Sponsor, Administrator, and Entrant.
